All accounts should be up to dated by the time the Tribal FA Petition is filed with the BIA. Please stop by an event table or contact Rolita at the Bedford Office to ensure your account is up to date. There will be new billing statements sent out in September at the start of the 2016-2017 Service Year. Members who have ***not*** responded due to returned mail or that cannot be contacted by the last noted phone number listed on file will be put on hold with FCIOO as well as the BIA.

It is important to update your account **before** open enrollment is **closed** during the Federal Acknowledgement petition review period. This rule is not a Tribal or FCIOO Departmental rule it is the requirement from the BIA so as not to cause confusion as to the current enrollment submitted with the BIA. Only current members will be able to update their accounts. FCIOO will not be accepting new enrollment during the petition review. Any new members will have to be added on the next enrollment submission. Any in-active members need to contact the office before the Petition is submitted.
