Petition report from the Tribal Council

We would like to thank the members of the Tribe and Family for their patience and diligence in assisting the council in acquiring the information needed for the Federal Acknowledgement process. It has been a long and tedious journey. However, we have not reached our final destination.

When we started the organizational process in 2004 by setting up FCIOO (The Federal Creek Indian Organization of Ohio, our tribal members Services Department) and RIEOSO (Research and Identification of Early Occupancy of Southern Ohio, the research, documentation and genealogy department), to manage the Tribe more efficiently, we knew the task would take time and the efforts of many.

At the onset we told the tribal members that this process could take 20 years or more to reach the goal of becoming a Federally Recognized Tribe and that there were many steps along this journey. All were eager and willing to step onto the path of this expedition with an unforeseen outcome. In 2004, we chose to be different from our ancestors by stepping into the public eye and speaking out against our isolation as a peoples. We have chosen the path of recognition rather than assimilation which some choose for fear of being outcast among the dominate culture. With this choice, we have taken on much derision, ridicule, contempt and mockery from among the public and even within our own family.

As indigenous peoples it takes effort, heart, compassion and strength to endure this task that we have embarked upon. Please understand that this journey is not over and we are still in need of the Families'/Tribe's participation, efforts, prayers and cohesiveness. Many have tried to break up or scatter the members with hopes of a faster process to reach Federal Acknowledgement or create false expectation and dreams of quick riches and wealth. However, this Council feels that with industrious effort, mindful prayer and accurate documentation we will reach our goal. "He that endures to the end" will see that this journey has been worth all the hard work, sweat and tears. It always seems darkest in the last hours and the Israelites waited more than 400 years for their delivery. In all these examples, hope has always aspired a higher level of achievement and we will follow in this same fashion. In the words of our peoples "Okahok Nedawahai" this is for ALL Our Relatives, past, present and future. Ever onward we progress.
